The Department may issue a High Achievement Scout License to an individual who is a bona-fide Arizona resident and is either: a member of the Boy Scouts United States of America, who has attained the rank of Eagle Scout; or a member of the Girl Scouts of the United States of America, who has attained the Gold Award.

This license is a reduced fee, youth class F combination general hunting and fishing license that grants all of the hunting and fishing privileges of the class F combination hunting and fishing license.

## **Required documentation:**
